BZA AND ZONING COMMISION HEARINGS: FEE MUST BE PAID AT THE TIME OF THE APPLICATION. SHOULD THE PARTY INVOLVED WISH TO CANCEL OR WITHDRAW THEIR REQUEST FOR THE HEARING, \$400 WILL BE RETURNED AND \$100 IS KEPT FOR ADMINISTRATIVE COST. HOWEVER, SHOULD THE REQUEST FOR WITHDRAWL COME AFTER THE ADVETISEMENT ANNOUNCING THE HEARING TO THE PUBLIC HAS BEEN MADE, THERE WILL **NO MONEY REFUNDED**.

THE ABOVE FEES ARE NOT AN INTEGRAL PART OF THE WAYNE TOWNSHIP ZONING RESOLUTION AND MAY BE CHANGED WITHOUT MAKING AN OFFICIAL AMENDMENT TO THE RESOLUTION.
