UNFINISHED BUSINESS

1. Heavenly Acres Update- We are close to having the County estimate, which then if we can come to an agreement with David White, we can get the project out to bid. David White is the residence where most of the work will take place. He has requested \$15,300 to permit us to the needed work outside of the easements. It was discussed that we should get this work agreement in front of the County Prosecutor to make sure it all looks good, and then when we receive the County Engineer's estimate we should have a meeting with the Heavenly acres resident's to discuss the upcoming project and requests from David White.

NEW BUSINESS

- 1. Senior Parade the Trustees thanked everyone who was involved in the senior parade. The community came together and supported our upcoming graduates and it was a success.
- 2. Recycling Dumpsters The recycling dumpsters had to go, there was years of abuse and wasted man-hours trying to keep the area clean around them. The whole dumpster of recyclables were usually not able to be recycled anyways because many non-recyclable items were placed in the dumpster. The Trustees apologized to those residents who did not abuse them but they felt they had no other choice.
- 3. Zoning Commission Seat The Trustees will request an executive session to fill the open seat on this Commission.
- 4. Tolbert Road Bridge Weather permitting this project should be complete in 2/3 weeks.
- 5. Shurz Road Bridge There will be no road closures for this repair. There are orange barrels in place in the North bound lane, the east side needs to be repaired.
- 6. Maintenance Building Roof It was decided to replace the maintenance barn roof with metal and to just repair the salt barn roof as we will be looking into replacing that whole building sooner than later.
