#### **CALL TO ORDER**

#### **APPROVAL OF MINUTES**

May 17, 2021 Regular Trustees Meeting

A motion to approve the May minutes was made by Tim Taylor, followed by a second by Ed Truster. Roll call was taken; 3 ayes, 0 nays, 0 absent.

#### **PRESENTATIONS**

- 1. Kelly Crout Butler SWCD gave a presentation regarding water and soil. Kelly is the Butler County District Director, she wanted to share local events and opportunities for the public. Free well water testing, covered crop workshop, ag pesticide drop off, creeking for kids, Metroparks family fun days was just to name a few. More information is available on their website.
- 2. Thomas Hall 53<sup>rd</sup> District State Representative- thanked the trustees for the opportunity to come give an update. He stated that he was looking forward to next year's OTA conference. He went onto explain multiple bills that were in the works. He then updated the township on ARP funds which the townships had been left out of. He explained there is currently legislation trying to get the townships included. Payments could come as soon as the end of July, with a second payment possibly next spring or summer. A discussion was had regarding the efforts being held regarding the Railroad crossing blocking tracks. Norfolk and CSX are both responsible, trying to make things better with the Railroad could be a long and hard road but he will continue to work towards a resolution.

#### REPORTS

Reports are attached.

- Fiscal Officer may need a special meeting before the July 19th regular meeting to approve the tax budget.
- Fire Runs are already at what they would normally be for a full year. This is a huge increase for our department
  and seems to be the trend from last year. The department may need to begin looking into what needs to be done to
  support this increase.
- Zoning- Ed Truster asked if Donnie Angst could get extra copies of the newsletter. Next, he stated that Butler County Board of elections are looking for Poll workers if interested please reach out to the board of elections. Daniel Hoit stated that he knows at the last meeting it was asked to see if the Normac bid included cutting and repairing base if needed, Normac stated it was all included in the bid as they did not see a need for that at this time. A discussion was had stating that the Fiscal Officer stated if we so decided to move forward with paving Hope and Celestial to go ahead and she will work out details when she returns.
  - A motion was made to accept and award the bid to Normac Paving for Heavenly acres subdivision not to exceed \$50,000.00 by Ed Truster, seconded by Tim Taylor. Roll call; 3 ayes, 0 nays, 0 absent.
  - Ed Truster asked if a grate could be placed on the pipe. Eric from the County stated they do not grate any outputs. Trustees still want a grate, please research why not.
- Ed Truster stated that the property lines have been located at the Dengler property. At this time Mr. Dengler seems to be in compliance with the court order. He then asked if a discussion could be held regarding how we are handling complaints and what is done if action is not taken by the homeowner to correct the issue. Finally, it was stated that Carlene Yeager has stepped down from the BZA, all the members of the board thanked her for her many years of dedication to the board and our township. After a short discussion, a motion to appoint Alternate BZA member Gary Witt to fill the vacated seat affective immediately was made by Ed Truster, followed by a second by Tim Taylor. Roll call was made; 3 ayes, 0 nays, 0 absent.
- Road Daniel explained that he has received complaints from a homeowner in the heavenly acres' subdivision regarding the water retention in his ditch line. The County has been contacted and the Engineer's office stated the ditch is doing exactly what it was designed to do. Homeowner David White stated that everything was working great except that when things were seeded they did not use straw and with all the rain the seed washed away and there was some streaming in the final grade of dirt. Finally, he stated some complaints regarding speed issues around the township, the Sheriff's dept. is beginning to stage in the Cotton Run Rd. area. Daniel suggested us invest in a speed sign so we can have our own data as well as being useful during traffic counts.

A motion was made to purchase the Evolution Speed Sign for a cost of \$2599.99 with accessories. \$2963.00 total was made by Tim Taylor, followed by a second by Ed Truster. Roll call was taken; 3 ayes, 0 nays, 0 absent.

- 5. Mosquito Dunks- were rec'd by the County to be used throughout the township and or offered to the public. A box of them will be left in the hallway by the Midpointe locker for the public.

He then congratulated Fiscal Officer Laura Daley for becoming a grandmother again!



I looked at the streets last Friday morning, below is my scope of work.

- Remove deteriorated pavement, replace w/ 301 bitum. aggregate base 6" (assumed 50 cy of repair)
- Cut butt joint at SR122, profile mill streets
- Apply tack coat, place variable depth 448 type 1 scratch course to seal cracked pavement and add crown to the streets (streets are flat)
- Place 1.5" 448 type 1 surface course
- No taxes included, will require the township to provide a tax exempt certificate
- Cost is \$79,500.00





The Butler County General Health District is pleased to be able to share these free mosquito dunks to assist in keeping you and your residents free from bites and diseases this summer! Please see information below on ways to distribute the mosquito dunks.

The dunks can be used in two ways: by your residents (you can hand out unopened packages to residents for use on residential properties), or by township staff for control of mosquitoes in larger publically owned areas (there must be a staff member who has an Ohio Department of Agriculture Pesticide Applicator's License)

Please feel free to use the dunks in whichever way meets your needs.
