He presented the cost of repairs that have been done to the current mower to keep it in service and explained that he felt it was time to replace it.

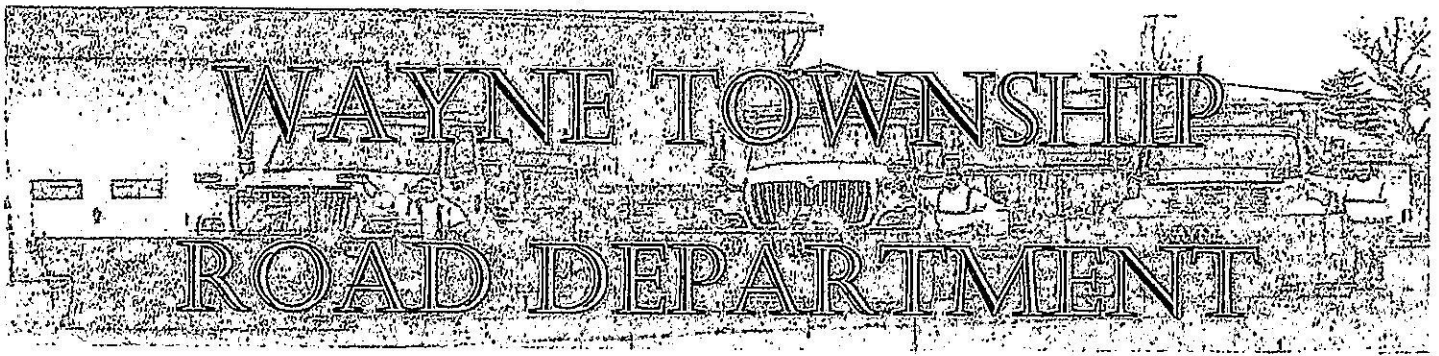
