CALL TO ORDER

NEW BUSINESS

- 1. Discussion on Solar Farms- A farm that puts solar panels in a field instead of crops. This is due to the push for cleaner power. Ohio is a good location for these solar farms because of the electrical infrastructure. Rural areas can benefit as farmers would receive annual payments with the possibility of grossing more than actually farming the land would be. The State put in a decommission bond in tact to make sure at the end of the contracted time that all equipment is to be removed and land put back in original condition. Also special training for Fire and EMS will be offered if any of these farms came to the Township.

AUDIENCE OF TRUSTEES

Tim Taylor - stated that he had been to the Dr. and they found that his heart was only functioning at 29%. He is scheduled for a procedure on November 29th. He stated if necessary he would be resigning his position as Trustee but before that happens he has things he would like to say. He stated that he had read Bill Jones' article from the Fall newsletter and it rubbed him the wrong way. He felt that Bill should have proof of the things he stated in his newsletter, he went on to criticize Fiscal Officer Laura Daley for the findings of the 2015-16 Audit where the prior Fiscal Officer Patricia Meek and prior board of Trustees were required to repay funds after a recovery for funds were found against them. Mr. Jones explained the points he made in the newsletter had been proven in previous public meetings, and in the actions from the previous board. He asked if Mr. Taylor wanted a response. Mr. Taylor stated he wanted proof. Mr. Jones explained that most he had witnessed with his own eyes and the rest can be proven through past experiences of Township resident's. When Mr. Taylor turned his attention back to Mrs. Daley, she reexplained to Mr. Taylor the findings from the '15-'16 audit was paid back and at that point she put it in the past. He was still upset, stating that the fiscal officer shared information before coming to the Trustees. She explained that was not true and that she worked for months with the State Auditor to get the amounts that were required to be paid back to a reasonable amount. He blamed bad Fiscal decisions and budgeting errors in the past for the mistakes. Mrs. Daley explained that all of this was before she took office and she could neither confirm or deny what caused the over payments of the Trustees and Fiscal Officer, she only knows what was found in that Audit. She stated that this was all in the past and this board and her only priorities should be the wellbeing of the Township and its residents

now. She asked that he let this go and focus on his own health and not dwell on things that were corrected six years ago.

Edward Truster – Stated he could not recall the misappropriation of funds from 2015 or previous but was only a part of the road crew and was possibly kept out of the budgeting errors.

Bill Jones – Stated that he hoped we can all move on from this as it was a long time ago and feels we have made great strides in the right direction since then.

Dear Butler County Commissioners,

The Wayne Township Board of Trustees has spoken with numerous residents and has been approached with questions in regard to limited internet accessibility in our Township. Our Township is fully committed to working to close the digital divide in our region and we hope to work with the County to achieve this goal. Accessible and affordable broadband is a lifeline to education, healthcare, and employment. The COVID-19 pandemic fully exposed the deficiency of broadband connectivity in Butler County and numerous residents were greatly impacted by the digital divide. We especially felt this in the Edgewood School District and we believe this is a critical issue of economic vitality and health. Some areas of Wayne Township still rely on Dial up connections due to very limited availability,

To address the gap in broadband connectivity, we propose that the County lead a County wide RFQ process to help our entire region address disparities in broadband internet access. If the County feels that taking a central role as a lead on an RFQ for this process is not the proper approach, then we recommend supporting the Butler Rural Electric Cooperative efforts. Their pending request that they have sent to you will help address this disparity for over 2,000 residents and significantly move the needle toward addressing the digital divide in our county.

If the County agrees to take a central lead in this effort, we agree to explore and establish our appropriate financial commitment toward these efforts using our American Rescue Plan Funds. We believe that by working together, we can strengthen the economic health of our entire region and close the digital divide.

Thank you for your consideration and we look forward to discussing a possible County wide partnership.
