## NOMINATION FOR VICE-CHAIR

Ed Truster nominates Tim Taylor, Bill Jones seconds; Roll Call; Bill Jones yes, Ed Truster yes, Tim Taylor yes.

#### CALL TO ORDER

Bill Jones Called the meeting to order at 7:08pm.

#### PROPOSED RESOLUTIONS:

- 2022-01) That all public meetings including but not limited to the regular monthly Trustee meetings, Trustee special meetings, Zoning Board meetings and Board of Zoning Appeals meetings shall be at a minimum video and audio recorded, saved and stored according to the requirements of record retention. The meetings will be broadcasted live via Facebook Live on the Wayne Township Butler County, Ohio page. Ed Truster motioned, Tim Taylor second; Roll call was held, all ayes.
- 2022-02) To appoint \_\_Tim Taylor\_\_ as the elected official to serve on the Butler County Emergency Management Agency Executive Committee for 2021. Ed Truster motioned, Bill Jones second; Roll call was held, all ayes.
- 2022-03) To appoint \_\_\_\_Bill Jones\_\_\_\_ and \_\_Tim Taylor\_\_\_\_ to serve as Trustee members of the Ohio Firefighters Indemnity Board. Doug Hoit (Chairman), Edward Truster (Secretary) and Gary Fall will continue to represent the Fire Department and the community on the Board. Ed Truster motion, Tim Taylor second; Roll call all ayes.

2022-04) To appoint \_\_\_\_Bill Jones\_ as the Wayne Township representative to the Butler County Health Board. Ed Truster motioned, Tim Taylor second; Roll Call- all ayes.

2022-05) To appoint <u>Austin Young</u> as the Road Superintendent. Ed Truster nominated, Bill Jones second; Roll call-2 ayes, 0 nays, 0 absent, Tim Taylor abstain.

2022-06) To appoint \_Doug Hoit\_ as the Fire Department Chief. Ed Truster motioned, Tim Taylor second; Roll Call – all ayes.

2022-07) To appoint \_Daniel Hoit\_ as the Fire Department Captain for 2021. Ed Truster motioned, Tim Taylor second; Roll Call- all ayes.

2022-08) To hold the 2021 monthly Trustee meetings on the third Monday of each month at 7:00PM in the Township Hall, except as follows:

1. January 18th-Tuesday meeting - 7PM (Monday 01-17-22 is Martin Luther King Day).

2. February 22nd-Tuesday meeting – 7pm (Monday 02-21-22 is President's Day)

Ed Truster motioned, Tim Taylor second; Roll Call- all ayes.

- 2022-09) To authorize the Fiscal Officer to pay all qualified bills by check containing at least two Trustee signatures. A report of all paid and unpaid expenses shall be listed and presented at the next available regular monthly Trustee meeting for approval by the Board. Ed Truster motioned, Tim Taylor second; Roll Call all ayes.
- 2022-10) To approve the permanent appropriations and authorize the Fiscal Officer to make all intra-fund transfers and appropriations modifications as listed per the attached permanent budget for January through December of 2020. Laura Daley presented some changes to the appropriations, and after reviewing every line item of the 2022 FY budget. Tim Taylor motioned, Ed Truster seconded; Roll call- all ayes.
- 2022-11) To approve the following 2022 pay schedule:
  - 1. Road Superintendent/Zoning Administrator/: \$20.00 to \$27.00 per hour.

## 2. Road Department:

Labor I - \$10.00 to \$15.99 per hour.

Labor 2 - \$14.00 to \$17.99 per hour.

Labor 3 - \$16.00 to \$19.99 per hour.

Labor 4 - \$18.00 to \$21.99 per hour.

Labor 5 - \$20.00 to \$23.99 per hour.

Labor 6 - \$22.00 to \$25.99 per hour

3. Fire Department:

Run Pay:

Firefighters and BLS/ALS-\$14/ Run

IN-training employees, 50% of run pay during probationary period. Not to exceed

one year within hire date unless approved by the Fire Chief.

Fire Chief -Asst. Fire Chief -

\$1800 annually + Run Pay based on Certification

Aloot, Life Chief.

\$1200 annually + Run Pay based on Certification

Squad Captain -

\$1800 annually + Run Pay based on Certification

Fire Captain - \$1200 annually + Run Pay based on Certification Fire Lieutenant - \$600 annually + Run Pay based on Certification Squad Lieutenant - \$600 annually + Run Pay based on Certification \$600 annually + Run Pay based on Certification

It was discussed that officers need to meet to consider the rates of the fire department and compare rates to other local departments for a possible increase. The Trustees will consider those increases at that time. Tim Taylor motioned, Bill Jones seconded; Roll Call- 2 ayes, 0 nays, 0 absent, Ed Truster abstained.

2022-12) Full time and part time employees shall be paid bi-weekly, life squad on-call payments shall be paid monthly and Fire/Life Squad run pay shall be paid annually unless otherwise modified by resolution and a majority vote of the Trustees. Ed Truster motioned, Tim Taylor seconded; Roll Call- all ayes.

2022-13) The following Trustees will assume oversight of the care and maintenance of the following cemeteries:

The Trustees determined they would like Daniel to also look into these rates to see if an increase is needed as well by comparing to other local townships. Ed Truster motioned, Tim Taylor seconded; Roll Call – all ayes.

2022-15) To approve the following travel, meeting and training expense policy for 2022.

l. Parking receipts will be reimbursed in full with qualifying receipt(s).

- 2. Meals, hotels and transportation will be fully paid with qualifying receipts to authorized meetings, training and events. Alcohol shall not be reimbursed.
- 3. Package deals that include extended stay with substantial discounts may be used if financially beneficial to the Township.
- 4. Mileage to be reimbursed at state approved rate.

Tim Taylor motioned, Seconded by Ed Truster; Roll call- all ayes.

2022-16) To amend Resolution 2022-11 by reinstating Township Administrator position with a pay scale of \$20.00-\$27.00 an hour.

Ed Truster motioned, Seconded by Bill Jones; Roll call- all ayes.

2022-17) To appoint Daniel Hoit as Township Administrator.

Ed Truster motioned, seconded by Tim Taylor; Roll call- all ayes.

2022-18) To approve a 1.75% Cost of Living increase for all full-time employees beginning the first payroll in Fiscal year 2022.

Tim Taylor motioned, seconded by Ed Truster; Roll call- all ayes.

2022-19) To approve a pay increase of \$0.30 an hour for Road Superintendent duties after the COL increase for Austin Young.

Ed Truster motioned, seconded by Bill Jones; Roll call- 2 ayes, 0 nays, 0 absent, Tim Taylor abstained.
