### **CALL TO ORDER**

Trustee Bill Jones called the July 15th meeting to order at 7:00pm.

### PLEDGE OF ALLEGIANCE

All stood for the pledge of allegiance to our flag.

### ROLL CALL

Roll call was taken; all trustees were present.

A moment of silence was requested in honor of Nick Dengler.

### **PRESENTATIONS**

### AUDIENCE OF PUBLIC

Tracy Halsey -4872 Thomas Rd. Calvin Short -4771 Thomas Rd. Linda Amann-4975 Thomas Rd. and Tina Longworth among other residents from Thomas Rd came to share their concerns of activities happening at 4951 Thomas Road. There have been multiple situations where the neighbors are concerned that the property owners are slaughtering animals and, in the past, possibly burning the carcasses. They now believe they have set up a pick up with Rumpke, but this past Friday, the Rumpke truck left a trail of terribly smelling guts and possible animal discards down the road. The complaint had been called in to a Trustee, who in turn notified Laura Daley, the zoning Inspector, to see if anything could be done about the odor and trail. She immediately dispatched the road crew and Tanker truck to clean the road. The residents also stated that there were water buffalo being kept on the property and due to them not having a proper water hole to wallow in, the water buffalo had gotten out of their enclosure and were trespassing in neighboring ponds.

Ms. Daley, Zoning Inspector, stated that this is not the first property within the township, she has received complaints regarding unlicensed processing of animals at additional addresses. She is aware of the issue, she has contacted the Butler County Health Department and the Department of Agriculture meat division. The Department of Agriculture will go on site and place a cease and desist on them, if they continue to operate without a license they will be cited by them. In order to get the Department of Agriculture involved she has to issue a cease and desist first and copy the complaint to their inspectors. The DOA takes this very seriously and have been very quick to act. A few things she wishes to share. Animal processing is not a permitted use



anywhere in the Township unless it is used for personal consumption only. Although there is a language barrier with those that are doing the unlicensed processing, most are willing to abide by the rules when explained things. She also went onto state that if anyone has photographs of the actions taking place at a neighboring property to please send those to her at the following email address: <a href="mailto:info@waynetownship.net">info@waynetownship.net</a> She explained that she is restricted in how she can obtain proof of actions and that she must have proof. The discussion continued and Ms. Daley stated she would keep the residents notified as the situation is resolved.

### APPROVAL OF MINUTES

• June 17th, 2024 Regular Meeting Minutes

A motion to approve the minutes of the regular trustees meeting was made by Trustee Ed Truster, followed by a second by Trustee Tim Taylor. Roll call was taken, 2 ayes, 0 nays, 0 absent, Trustee Bill Jones abstained due to being absent from the June 17<sup>th</sup> meeting.

- Fire hydrant testing is being performed by the Department throughout the Township, the maintenance of these hydrants is the responsibility of Southwest Regional water, but our department had not received any feedback for some time and the F.D. needs to be aware of any issues with hydrants before they arrive at the scene of a fire. In the testing of our hydrants we found nearly 20 bad hydrants throughout the Township. Southwest regional will be notified of their locations.
- Road Trustee Ed Truster asked if the speed sign was repaired. It was explained that it was indeed
  showing speeds but was not communicating or keeping record so that this would not help to inform us
  if an actual speed study was needed where we had received complaints.

That if needed amounts can be adjusted if any major changes need to be made. Trustee Ed Truster made a motion to approve the adoption of the FY 2025 Tax budget and to submit the same to the County Budget Commission, followed by a second by Trustee Tim Taylor. Roll call was taken; 3 ayes, 0 nays, 0 absent.

2. A MOTION TO APPROVE <u>GRACIE KOELBLIN, EMT</u> TO THE WAYNE TOWNSHIP FIRE DEPARTMENT ROSTER PENDING RECIEPT OF ALL PAPERWORK.
