- Fund reports and current budgets are available upon request.
- Prepared first steps of Community Grant Writing project where we will be working with Professor Matthew Nunes from Miami University and his English 413 Grant and Proposal writing class this Fall of 2024. An introduction to the township and three grant writing proposals needed to be submitted by 08/12/24. A virtual trustees meeting will need to be held with them as well as virtual communications between myself and the students to answer any questions. quotes and information on why the Township would benefit from the items we request to acquire from these grants must be provided in a timely manner. The key benefit for us (the community partner) is that the students will prepare grant proposal drafts to help fund programs/projects for us. We may then use the grant proposal drafts as it likes by submitting the proposals to different funders. The students do not submit the grant proposal rather just give us their proposal's that have been written as their semester grade and carefully critiqued by the professor. The class is usually made up of 20 students and the assignment will be a group effort of 3 or 4 students. So as this may be time consuming for myself, we may end the course with 5 or 6 grant proposals we could submit for funding. I sent a request to all departments and received feedback. After speaking with Prof. Nunes, we will begin with three proposal's that have different levels of funding needs. 1. Tornado Sirens 2. Cemetery Surveying and plotting at Simonson Chapel Cemetery. 3. An equipment grant- for either the Road department in the form of a mini ex. or possibly a dump truck or for the Fire department for the purpose of a new Brush truck or a side by side 4-wheel drive recreational vehicle. Each department will be responsible for obtaining quotes for the exact equipment they would like to propose the grant to be written for, but time is of the essence and must be submitted soon. I have already been in contact with a few surveyors regarding getting quotes for the cemetery proposal.

\*Several complaints have been received regarding multiple properties attempting to process animals on their property. This is not a permitted use anywhere within the Township with the exception of fowl or for personal consumption of the land owner. I have had multiple conversations with property owners and tenants throughout the township, the restrictions have been explained to them thoroughly regarding the seriousness of marketing unlicensed processed meat. The Butler County Health department and the Department of Agriculture are involved in remedying the situation.

- 3952 Taylor School Rd. Excessive junk.
- Complaints
  - noxious weeds unimproved land arrowhead estates (4 lots received complaints, 2 have already mowed.)
  - encroaching on property. Complaint was received by two separate residents regarding two separate properties. I looked into situation, neighboring properties are excavating over staked property, explained that this was a civil dispute and that the Township was unable to get involved.
